Leading The Way In Childhood Literacy: Out of the 15 state colleges that train future North Carolina teachers, UNC Charlotte's Cato College of Education received a "highest rating overall in literacy instruction," as stated in <u>this</u> UComm article. The story also featured a recent UNC Charlotte graduate, Caitlin McGennis, as she put her dual elementary and special education major to work with 3rd graders at Berewick Elementary School in South Charlotte. McGennis took students through a writing exercise designed to develop reading skills and critical, independent thinking. DIVISION SPOTLIGHT THE OFFICE OF SPONSORED PROJECTS ADMINISTRATION (OSPA)

The Office of Sponsored Projects Administration (OSPA) helps faculty, staff, and students manage their research grants to ensure financial compliance and proper accounting on sponsored awards. OSPA joins a research project the moment an award is released and sticks with it even after the research is done. OSPA is led by its Executive Director, Darl (Darlene) Booker, and has four focus areas:

- Award Management Setting up grant award funds, managing award budgets and invoices, and ensuring every aspect of the award is compliant with local, state, and federal guidelines
- **Financial Compliance** Overseeing cost-sharing, any external grant fund audits, patent/invention reporting, and financial reporting
- **Subrecipient Monitoring** Monitoring sub-awards, processing sub-award invoicing, conducting desk reviews, and more
- Award Closeout Closely monitoring project end dates, ensuring all budget release approvals are complete, final financial expenditure reporting, and final patent/invention reporting

As Booker explains, everything that touches a researcher's fund has to run through OSPA. "Whether it's international travel, award salaries, or subcontractor invoices, we review any type of expense that actually hits that award, just to make sure it applies to the grant," shares Booker.

Booker adds OSPA is driven by strict compliance and a love for research. "We care deeply about the sponsored projects and seeing that the primary investigators (PIs) make a positive difference with their work. So we are committed to making sure that there are no compliance weaknesses or short-comings so we can continue to receive funding into the university."

The OSPA team is made up of 12 amazing personnel. The office went through a name change recently so if you're still hearing or saying "Grants & Contracts Administration" or "GCA," you're not alone. But we're excited about the new name AND even more excited that OSPA offers the same great support and oversight that helps accelerate our local to global world-class research. So say it with us...
